### **Delivery of steel balls for Drum ball mills in FGD under technical specification, ref. No 119-123-14**

Dear Ladies and Gentlemen,

On the grounds of art. 89, para 1 of the Public Procurement Act and on the basis of Decisions for announcement of results after preliminary selection in qualification system No 123-105-13 with subject: Delivery of steel balls for limestone ball mills in TPP ContourGlobal Maritsa East 3, for which an announcement ID 634662/24.11.14 has been published, we kindly invite you to participate in public procurement procedure with announcement with subject: **Delivery of steel balls for Drum ball mills in FGD under technical specification** as well as to present a technical and price offer.

1. **Technical offer** consisting of following documents:

Participants submit their /technical and price/ offers in separate sealed envelopes to following address: 6294 Mednikarovo, Stara Zagora District, ContourGlobal Maritsa East 3 AD, Commercial department.

Deadline for offers submission: 09.12. 2014, until 10 o'clock.

The committee shall review technical quotations on 09.12. 2014, at 10 o'clock in the meeting room of ContourGlobal Maritsa East 3 AD, Mednikarovo village, Stara Zagora District, as candidates' presence is not obligatory.

After preliminary evaluation of offers Contracting Authority shall send an invitation for participation in electronic tender to all participants whose offers comply with stated requirements. Negotiation of price offers shall be conducted by electronic tender which may be administered in one or more stages. Committee members decide the concrete necessity for a second and next stage of price negotiation, for which participants shall be informed after completion of first stage. The criterion for offers evaluation is "best negotiated price".
